# ADDENDUM TO TEEN DRIVER EDUCATION CONTRACT

## CONTRACTUAL TIMELINES: **CONTRACTUAL TIMELINE IS TEN (10) MONTHS**

- If a student successfully completes 24 classroom hours within the contractual timelines, they may keep that phase of instruction, and transfer it to another class, another commercial school, or to the parent-taught program. They will not be required to repeat the classroom phase of the course.
- If a student completes 23 classroom hours and the contractual timeline ends, the student loses all classroom credit hours and must retake the entire classroom phase.
- If a student completes 24 classroom hours, 6 hours of driving and 6 hours of observation and the contractual timeline ends, the student may keep the 24 hours, but loses the 6 and 6. They must **RETAKE** the in-car portion. Re-enrollment fees may apply.
- If a student completes 24, 6 and 6 and the contractual timeline ends, the student loses ALL credit and must take the entire driver education course over again. New fees apply.
- Only the 24 hours of classroom credit can be transferred when a student exceeds the contractual timelines and want to transfer to another class, another commercial school, or to the parent-taught program.
- A new contract or variance (extension) may be executed to extend a timeline **ONLY** if it is done **PRIOR** to the completion timeline of the original enrollment contract.
- Any re-enrollment or variance charges must be clearly communicated to parent/student and agreed to in writing by all parties. They are as follows:

**Outside the standard TEN (10) month timeline - \$50.00 Re-enrollment Fee**

Outside a twelve (12) month timeline - \$125.00 Re-enrollment Fee

ANY Duplicate DE964 Certificates are \$20

## VARIANCES (EXTENTION OF TIME TO COMPLETE)

- Schools may grant a variance or execute a new contact **only** if it done prior to the completion timeline of the original contract.
- Variances may be made at the discretion of the school owner and parent/guardian must agree to it in writing.

I understand that my student is **required to drive at least 30 hours at home (5 hours in between each drive)** with a licensed driver over the age of 21 and to keep a log of these hours to be turned in to the DPS office when he/she is ready to get his/her **PROVISIONAL DRIVER LICENSE**.

I understand that my student **has ten (10) months** to successfully complete this 38 hour course in order to retain his Instruction permit and eventually receive a Provisional Texas Driver License or the above fees may apply. Failure to complete the requirements can result in termination of this contract. I understand my student should be scheduling a drive once a month to finish by their deadline.
